STEFANI, the undersigned, hereby associate STEVREINA POMPANO, INC for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that STEVREINA POMPANO, INC have become such corporation under and pursuant to the following Articles of Incorporation.
