

ARTICLES OF INCORPORATION

Garza Produce, Inc.

Article 1. The name of this corporation shall be Garza Produce, Inc., and the street address of the initial principal office ~~of this professional association~~ shall be 2217 44th Terrace Southwest, Naples, FL 34116.

Article 2. This corporation shall have perpetual existence.

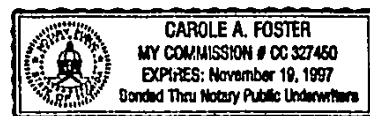
