
ARTICLE IX

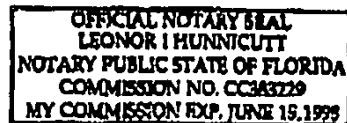




