The name of the corporation is **FEVER DREAM PRODUCTIONS, INC** The principal address of the corporation is: 1548 52ND STREET, GULF, MARATHON, FLORIDA, FL33050.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
