The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: ORLANDO RODEO MEX-MEX, INC. The principal office of the Corporation is 7839 Sugar Bend Drive, Orlando, Florida 32819.

<u>Article 2. Duration</u>. The duration of the Corporation is perpetual.
