**ARTICLES OF AMENDMENT TO

**MOORE PAINT & WALLPAPER, INC.**

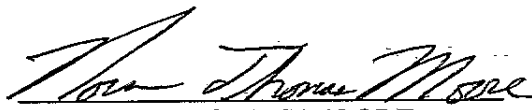
