ARTICLES OF INCORPORATION

OF

XL-CARE AGENCY, INC. OF SARASOTA

The undersigned, acting as incorporator of XL-CARE AGENCY, INC. OF SARASOTA under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
