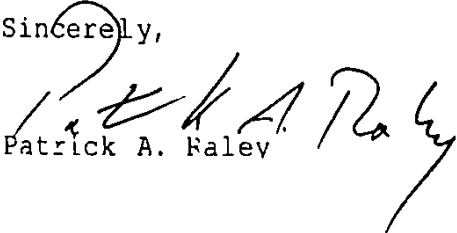

ARTICLE I

The name of this corporation shall be:
ON LOCATION MANAGEMENT, INC.

ARTICLE II

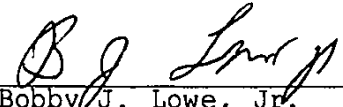

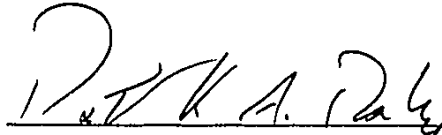
