ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Charles <sup>H</sup>W. Weston, D.C., P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
