The undersigned subscribers to these Articles of Incorporation person competent to contract, do hereby associate together to form a corporation for profit under the laws of the State of Florida. Corporate existence shall commence upon the filing of the Articles of Incorporation by the Department of State.

ARTICLE I.

The name of the corporation is **HIGHTOP CONSULTING, INC.** The principal place of business of the corporation will be 15463 Durnford Drive, Miami Lakes, FL 33014.

ARTICLE II.

General nature of the business or businesses to be transacted by this corporation is:

- (a) To do any and all of the acts and to exercise any and all of the powers now or hereafter authorized under the laws of the United States and the State of Florida to be done or exercised by corporations organized for profit.
- (b) To do any and all of the things herein set forth and everything necessary, suitable or proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or the furtherance of any of the powers, of which shall appear to be conducive or expedient for the protection or benefit of this corporation to the same extent as natural persons might or could do, and in any part of the world
