ARTICLE I. NAME

The name of the corporation shall be

The principal place of business of this corporation shall be 7945 Dildo Boulevard, Miramar, Fl 33023.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful business or activities as permitted under the laws of the United States, the State of Florida or any other State.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1 par value per share.

ARTICLE IV. ADDRESS

ARTICLE V. TERM OF EXISTENCE
