ARTICLES OF INCORPORATION

OF

MARLO CONSTRUCTION, INC.

I, MARK S. LONDON, being of legal age, do hereby sign these presents for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I - NAME
