These Articles of Incorporation may be amended by the Board of Directors in the manner provided by law.



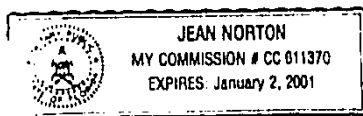


