Pursuant to the provisions of Section 607.1006, this Corporation hereby adopts the following Articles of Amendment to it's original Articles of Incorporation.


ARTICLE I - That the Corporation formerly known as Sams And Lister, P.A. shall now be know as Sams, Lister, & Hollon, P.A.
