Name

The name of the corporation is ULTRAMATIC SLEEP OF FLORIDA, INC.

ARTICLE II

Duration

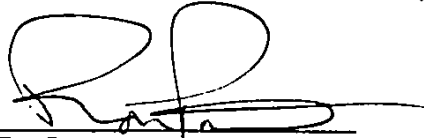
