# ARTICLES OF INCORPORATION OF NORTH GEORGIA SPRINGS, INC.

## **ARTICLE 1 - NAME**

The name of the Corporation is NORTH GEORGIA SPRINGS, INC. The mailing address of the Corporation is 160 County Road 29, Lake Placid, Florida 33852.

## **ARTICLE II - DURATION**

The Corporation shall have perpetual existence commencing on the date of filing these Articles of Incorporation with the Florida Secretary of State.

## **ARTICLE III - PURPOSE**

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

## ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 100,000 shares of capital stock with no par value, which shall be designated "Common Shares."

## **ARTICLE V - PRE-EMPTIVE RIGHTS**
