

ARTICLE I

Name

The name of the corporation is K&L CONSTRUCTION CONSULTANTS, INC. and its principal business address is 1012 Hastings Court, Lutz, Florida 33549.

Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholder(s) is subject to this reservation.

ARTICLE X

Bylaws

The bylaws may be adopted, altered, amended, or repealed by either the shareholders or the Board of Directors, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaw is not subject to amendment or repeal by the directors.

Beginning of Corporate Existence

Corporate existence shall begin upon the filing of these Articles of Incorporation.

The Offices of the corporation will be performed by the following individuals who are also the Directors of the Corporation:




