**Name**

1.1. The name of the corporation is **9162, INC.**

**ARTICLE II**

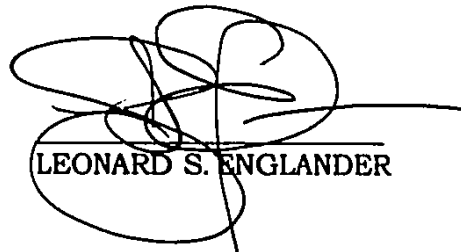

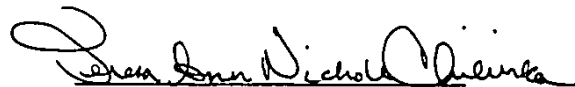
