ARTICLES OF INCORPORATION

OF

PATRICIA A. CORNETT, INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

PATRICIA A. CORNETT, INC.

The name of the corporation shall be: **PATRICIA A. CORNETT, INC.**

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of **JULY 1, 1997**.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

1. To conduct business in accounting and tax services.
2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT
