**ARTICLES OF AMENDMENT  
OF

The Articles of Incorporation of this corporation were originally filed on June 5, 1997. These Articles of Amendment are filed and applicable to Article IV only.

1. Article IV. of the Articles of Incorporation of West Wind Village Mobile Home Park, Inc., filed on June 5, 1997, is now amended to read as follows:

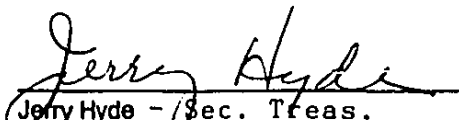
**ARTICLE IV. CAPITAL STOCK**
