## ARTICLES OF INCORPORATION OF

SENIORAID, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE I

The name and initial address of this Corporation shall be: SeniorAid, Inc., 6372 N.W. 25th Way, Boca Raton, Florida 33496, with the privilege of having its offices and branch offices at other places within or without the State of Florida.

#### ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock are as follows:
