ARTICLE ONE



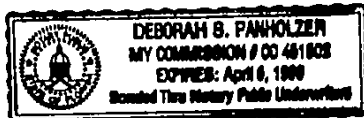
