

### ARTICLES OF INCORPORATION

OF

#### PBD ESTATE CORP.



## ARTICLE I

The name of the corporation is PBD ESTATE CORP. and its mailing address and principal place of business is 288-Z Smith Sundy Road, Delray Beach, Florida 33446.

## **ARTICLE II**

The corporation shall have perpetual existence.
