the undersigned, for the purpose of forming a corporation under the following articles of incorporation .

ARTICLE I
NAME

the name of this corporation is STORE PLANING & DESIGN , INC.

EFFECTIVE DATE

6/1/97

ARTICLE II
DURATION

this corporation shall exist perpetually commencing on the date of execution and acknowledgment of these

ARTICLE III
PURPOSE

this corporation is organized for the primary purpose of retail store planning and design and any other lawful business .

ARTICLE IV
CAPITAL STOCK

this corporation is authorized to issue seven hundred and fifty shares (750) at one dollar (\$ 1.00) par value common stock , which shall be designated "common shares ".

ARTICLE V
PREEMPTIVE RIGHTS

every shareholder, upon the sale for cash of any new stock of this corporation of the same kind class or series as that which he already holds, shall have the right to purchase his pro rata share as nearly as may be done without issuance of fractional shares .

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

BYLAWS

the power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders .

RESTRICTIONS ON TRANSFER OF STOCK

shares of capital stock of this corporation shall be issued initially to the following person and in the amount set opposite the name .

CUMULATIVE VOTING

at each election for directors every shareholder entitled to vote in the election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares ,or by distributing the votes on the same principle among any number of candidates .

AMENDMENT

this corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment to them ,and any right conferred upon the shareholder is subject to this reservation .

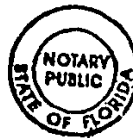
