ARTICLE I

The name of the corporation is LASTAR MANAGEMENT CORP. and its mailing address and principal place of business is Suite 351, 4830 West Kennedy Boulevard, Tampa, Florida 33609.

ARTICLE II


**ARTICLE IX**

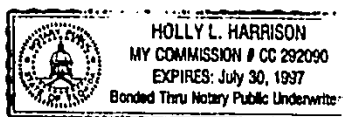
