# ARTICLES OF INCORPORATION

FOR

### KYLE TRANSPORTATION, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of the Corporation is KYLE TRANSPORTATION, INC.

#### ARTICLE II: DURATION

The Corporation shall have perpetual existence.

### ARTICLE III: PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in the comporation and business for which the corporations may be incorporated under the Florida General Corporation Act.

### ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is One HUNDRED (100) shares of common stock having a par value of One (\$1.00) Dollar per share.

# ARTICLE V: SECTION 1244 STOCK
