SECTION OF PHY 4: 03 The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I

# NAME

The name of this corporation is E.C.O.S. RAINFOREST, INC.
