ARTICLES OF INCORPORATION

OF

SEA-LAND PROPERTIES, INC.

SECRE ALLAHASIN APRILED The undersigned natural person, having capacity to contract and acting as the Incorporator of this Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for such Corporation, to-wit:

ARTICLE ONE: NAME AND PRINCIPAL OFFICE

The name of the corporation is: SEA-LAND PROPERTIES, INC. The address of its principal office is: 101 Sunny Lane, Reeds Spring, Missouri 65737.

ARTICLE TWO: COMMENCEMENT AND DURATION

The Corporation is to commence its existence upon the filing of these Articles by the Department of State, and will exist perpetually thereafter unless earlier dissolved in the manner prescribed by law.
