The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME

ARTICLE IX - AMENDMENT

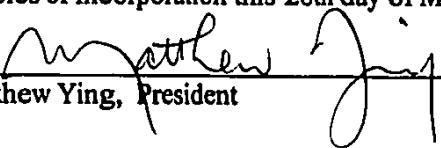

The date of commencement of corporate existence shall be July 1, 1997.

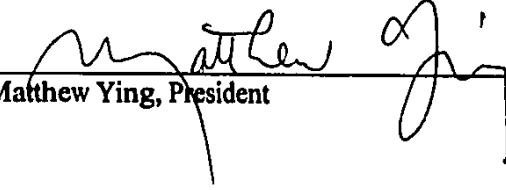
