**ARTICLES OF INCORPORATION
OF
PANTHERS BOCA LIMITED PARTNER, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is PANTHERS BOCA LIMITED PARTNER, INC. (hereinafter called the "Corporation").
