ARTICLE I.

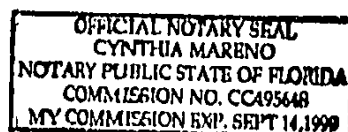

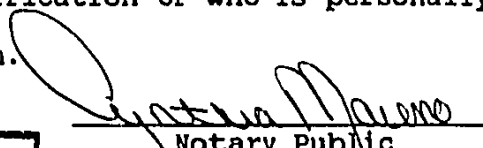

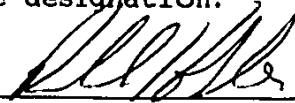
