## ARTICLES OF AMENDMENT OF JACOBONI REAL ESTATE, INC.

(By vote of Shareholders, or by Incorporators, or the Board of Directors without Shareholder Action)

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the Undersigned Corporation Adopts these Articles of Amendment.

FIRST: The name of the Corporation is <u>IACOBONI REAL ESTATE, INC.</u>

SECOND: The Articles of Incorporation of this Corporation are amended by changing the Articles numbered "I" and "II" so that, as amended, said Articles shall read as follows:

## ARTICLE I - Name of Corporation

## ARTICLE II - General Nature of Business
