ARTICLES OF INCORPORATION

of

A.R.K.O. INDUSTRIES. INC.

The undersigned, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is A.R.K.O. INDUSTRIBS. INC.
