
ARTICLE X

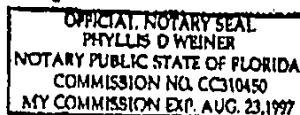
