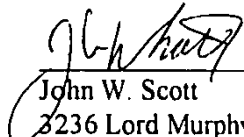
The original incorporators of this corporation shall have the right to assign and deliver their subscription of stock herein to any other persons who may hereafter become

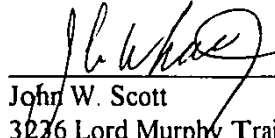
#### ARTICLE XI
