ARTICLE I.

NAME

The name of this corporation is B. Wolfson, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is 660 Capri Boulevard, Treasure Island, Florida 33708.

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of June 4, 1997.

ARTICLE IV.

PURPOSES

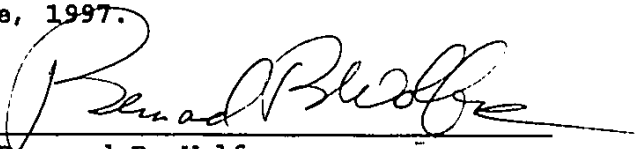
