The undersigned, who is duly licensed to practice dentistry in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act, Professional Service Corporation and Limited Liability Company Act adopts the following Articles of Incorporation:

I. NAME

The name of the Professional Corporation is: VICTOR J. BELIVEAU, ^{DMD}~~D.D.S.~~, P.A.

II. PURPOSE

The purpose for which the corporation is organized is to practice the profession of dentistry.

III. ELECTION UNDER PROFESSIONAL CORPORATION ACT
