Name

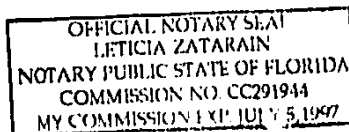
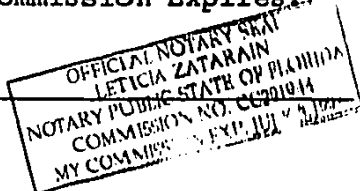
