ARTICLES OF INCORPORATION

OF

FIRST FLORIDA TITLE GROUP, INC.

I. NAME

The name of the corporation is FIRST FLORIDA TITLE GROUP, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.
