ARTICLES OF INCORPORATION



ARTICLE I - NAME

The name of this corporation is Evans Gallery, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 801&803A E. Las Olas Blvd Fort Lauderdale, Florida 33301

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
