**ARTICLES OF INCORPORATION**

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is STEPHEN T. MILLAN, P.A., and the address is 8603 Dixie Highway, Suite 208, Miami, Florida 33143.

**ARTICLE II - DURATION**

The corporation is to commence its corporate existence on the date of the filing of these Articles of Incorporation and shall exist perpetually thereafter until dissolved sooner according to law.

**ARTICLE III - PURPOSE**

The corporation will engage in the practice of law under laws of the U.S. and this state for profit. Furthermore, the above corporation is organized to conduct any and all other lawfully related business.
