ARTICLES OF INCORPORATION
of
STEVEN A. MEDINA, P.A.

The undersigned incorporator, who is licensed or otherwise legally authorized to practice law in the State of Florida, for the purpose of forming a professional corporation under the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation for the corporation.

ARTICLE I Name

The name of the corporation shall be: Steven A. Medina, P.A.

ARTICLE II Purpose

The purposes of the corporation shall be:

- a. to engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- b. to own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

ARTICLE III Powers

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of Florida.
