THE UNDERSIGNED, acting as sole incorporator of **FLOYD-BASSETT, INCORPORATED** (the "Corporation") under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name


