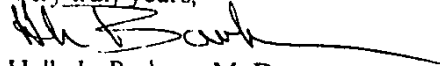

ARTICLE I - NAME

The name of this corporation is Laser Medical Arts of Sarasota, Inc. (the "Corporation").

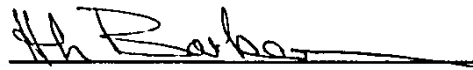
