ARTICLES OF INCORPORATION
OF
DELTONA NURSERY, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I - NAME

The name of the corporation is DELTONA NURSERY, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE IV - PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of nursery-related activities and landscaping services.
2. 


