The undersigned subscriber to these Articles of Incorporation make, subscribe and acknowledge the following Articles of Incorporation under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be:

ARTICLE II - TERM OF EXISTENCE

The Corporation shall begin its corporate existence as of felling of these Articles of Incorporation and shall exist perpetually.
