The undersigned subscriber hereby makes, subscribes, acknowledges, and files these Articles of Incorporation with the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit in accordance with the Florida Business Corporation Act, Chapter 607, Florida Statutes.

**ARTICLE ONE  
NAME AND MAILING ADDRESS OF CORPORATION**

The period of duration of the Corporation shall be perpetual commencing on the date of execution and acknowledgment of these Articles.

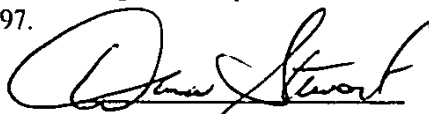
**ARTICLE FOUR

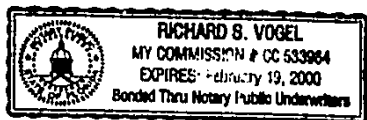

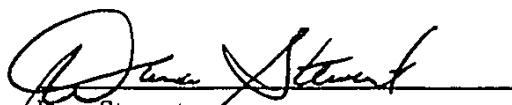
