The undersigned Subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be:

ECONO PRO PEST SERVICES INC.

ARTICLE II

The general nature of the business to be transacted by this Corporation is: The sale and solicitation of pest control services, planning and advising individuals and various businesses and organizations concerning pest control and to do all other acts and things incidental thereto or included in all or any of the general powers given private Corporations for profit under the Laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time shall be five hundred (500) shares of common stock having a par value of One Dollar (\$1.00).

ARTICLE IV

The amount of capital with which this Corporation will begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE V

The street address of the initial registered office and principal place of business of this Corporation is 1102 68th St. West, Bradenton, Florida and the name of the initial Registered Agent is PAUL DONNOLO. The Board of Directors may from time to time move the registered office to any other address in Florida.

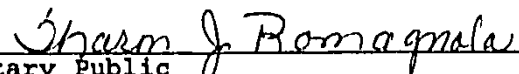
