### **ARTICLES OF INCORPORATION**

## **ALL EVERYTHING CORPORATION**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

# ARTICLE I - NAME

The name of this Corporation is ALL EVERYTHING CORPORATION.
