NAME



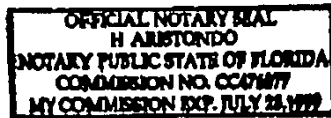


